As well as providing day to day legal support to the business you will assist with the development and implementation of legal strategy within the division.

International Rail Lawyer – *2- 5 PQE, London

Working closely with the General Counsel of the Rail Division, you will provide support on a range of commercial, projects and regulatory matters globally. Candidates will be considered from a range of different legal disciplines as long as you bring a keen intellect and genuine energy to the role. Business travel will be required.

To take on any of these roles, it is likely that you will have trained and spent some time post qualification in a leading law firm or in-house team. You will be a commercial, pro-active and agile lawyer who focuses on “preventative lawyering”, essentially identifying and avoiding legal risks before they materialise. You will deal with people from many different professional backgrounds on a daily basis and as such, strong inter-personal skills are key. Equally important is the ability to inspire confidence in order to be seen as a credible and trusted business adviser.
